Tax Forum met with the Directorate General of Foreign Trade (DGFT) to deliberate on a range of concerns related to India's import policy, including regulatory challenges, procedural issues, and its impact on trade stakeholders.

20 May, 2025



The Safety of Household, Commercial and Similar Electrical Appliances (Quality Control) Order, 2025, notified by DPIIT on May 19, 2025, mandates BIS certification for electrical appliances rated up to 250V (single-phase) and 480V (DC and others) used in household and commercial applications.

The order will be effective from March 19, 2026, for general manufacturers, June 19, 2026, for small enterprises, and September 19, 2026, for micro enterprises.

Exemptions apply to R&D imports (up to 200 units/year), pre-implementation stock (with declaration), and appliances already covered under other QCOs.
